



Two-Way Parent/Guardian Collaboration

In all cases, every effort should be made to engage parents/guardians in direct, two-way communication when concerns regarding a student's performance or behavior arise. Students and parents/guardians should be encouraged to utilize school-based resources, including instructors' extra help nights, individual tutoring, student mentors, conduct or discipline referrals, attendance monitoring, and consultation with school counselors, CTE coordinators, assistant principals, special education personnel, etc. for support. The ENSATS <u>District Curriculum</u> <u>Accommodation Plan (DCAP)</u> should also be referenced and implemented as appropriate.

TOS -TIER ONE SUPPORT REFERRAL To the student's Assistant Principal and/or CTE Director

A "Tier One" intervention engages the Assistant Principal and/or CTE Director and School Counselor in an effort to address a concerning trend in school performance, attendance, behavior, etc. at an early stage. This generally occurs

- ✓ After referral source (instructor) has had two way communication with the parent/guardian.
- ✓ Frequently when the student does not have other identified supports in the school environment if applicable (i.e.: special education liaison, school adjustment counselor, 504 Plan contact, school nurses, etc.)

SST- STUDENT STUDY TEAM (SST) REFERRAL To Jennifer Skane, Assistant Principal

Following an SST referral from a faculty or staff member, an interdisciplinary team of educational professionals (including but not limited to Administration, Counselors, Special Educators, School Nurses, etc.) collaborate to assess the impact of past interventions and identify additional strategies, interventions and/or actions to support a student who has demonstrated an ongoing pattern of concerning academic, career technical and/or social emotional performance despite Tier 1 or other previous interventions.

- ✓ Tier 1 Referral and/or other interventions implemented without resulting in reasonable progress or improvements
- ✓ Will result in an SST Action and/or Monitoring Plan

IR - IMMINENT RISK REFERRAL: IMMEDIATE & DIRECT COMMUNICATION MUST BE MADE TO A SCHOOL COUNSELOR or ADMINISTRATOR; An email or voice mail IS NOT sufficient in these instances.

- Risk or Harm to Self or Others (e.g.: <u>Suicidal ideation/plan, self-harm, etc.)</u>
- 51A Mandate: Abuse, Neglect, or Sexual Exploitation _______
 School personnel are mandated reporters and legally obligated to contact the Massachusetts Department of
 Children and Families (DCF). If school personnel have reasonable cause to suspect physical or emotional abuse or substantial risk of harm/neglect of a student under the age of 18, 51A reporting to DCF is required. See: A Guide for Mandated Reporters

ENSATS Contact Protocol for Imminent Risk Referral

- Assigned School Counselor... if DIRECT contact is not made then...
- *Assistant Principal or Director of School Counseling...if DIRECT contact is not made then...
- Any Director or Administrative Assistant or call the Main Office "x1010" who will then radio/text for Administration
