



2025 ENTERTAINMENT LICENSE

At the regular meeting of the held on June 3, 2025, by a motion duly made and seconded the Select Board voted to grant an **7 Day Entertainment to The Larkin Event Center, LLC, d/b/a The Larkin, 562 Maple Street**, Danvers; in accordance with Chapter 140, Section 181 of the General Laws which is quoted herewith:

"Chapter 140, Section 181 (weekdays, including Saturdays). Chapter 136, Section 4 (Sunday) Innholder, victualler, cafe, restaurant, eating or drinking establishment. - No innholder, common victualler or person owning, managing or controlling a cafe, restaurant or other eating or drinking establishment shall, as a part of his usual business, offer to view, set up, set on foot, maintain or carry on a concert, dance exhibition, cabaret or public show of any description at which food or drink or other refreshment is sold for cash, or in connection with which, after free admission, music or other amusement is provided or furnished upon payment or deposit of money, either as a cover charge or in payment for food, drink or other refreshment, unless and until a license therefore, to be exercised on weekdays only, has been issued by the licensing authorities, who may upon written application and upon such terms and conditions as they may prescribe, grant such a license for any or all of the purposes hereinbefore described and may, after written notice to the licensee, suspend, or, after hearing revoke the same. Licenses granted under this section shall specify the street and number where the licensed business is to be carried on or give some particular description thereof, and shall not protect a licensee who carried on his business in another place. Such licenses, unless sooner revoked, shall expire on December thirty-first of each year. The fee for any such license or for renewal thereof shall not exceed five hundred dollars, but no fee shall be chargeable for any such license to a person who, for the period covered by such license, is also licensed under section two."

This license is subject to the following conditions:

Must appear before Select Board in December to provide an update prior to renewal.

1. No live entertainment, speakers, PA equipment, or sound amplification devices are allowed outside of the physical building.
2. Entertainment must stop by 9:00 p.m. every night.
3. When entertainment is taking place in the building, windows should remain closed.
4. Except for school-sponsored events, the use of an entertainment license is restricted to no more than three days in a calendar week, from Sunday through Saturday.
5. The school provides the Board with a methodology for receiving and tracking neighbor issues (by phone or email), including appropriate dates, times, contact information, and resolutions. This information should be available in the event the Board calls for action at future meetings.
6. The school will document a methodology that demonstrates how a neighbor can reach someone, during event hours, with the authority to manage the ongoing event. Contact information will be posted on the school website.
7. The school will document how parking lot use will be monitored during the event and identify who the neighbors can contact on-site at the time of the event.

This license is also subject to the Rules and Regulations of the Licensing Board of the Town of Danvers Establishing a Code of Conduct and Dress in and on Premises Licensed in Accordance with General Laws, Chapter 138, Sections 1, 12, 14, & 23.
